On-site experience in clinics and programs is balanced by weekly colloquia and intern meetings that provide a venue to discuss research, evaluate evidence-based treatment, analyze how client-informed approach directs treatment, participate in case discussions, and meet with psychologists from the community to learn about their areas of specialty. Collectively these activities provide interns opportunities for meaningful exchange of ideas on topics of relevance for psychologists and deepen their understanding of psychology as a

profession. The Southwest Behavioral Health internship program is a member of the Association of Psychology Postdoctoral and Internship Centers (APPIC) and the American Psychological Association (APA). SBHS Psychology Internship program espouses the philosophy of the Practitioner-Scholar model of training, which grew out of the conference on Professional Training in Psychology held in Vail, CO in 1973. The program seeks to continue the clinical training the intern began through previous field placements and practica. The Internship program takes 2000 hours over a period of 12 months to complete.

- ***Responsibilities:*** The psychology interns will receive a wide range of training experiences in core competencies during the course of their internship year. Through supervision, colloquia series, and on-site experiences, Psychology Residents will have ample opportunities to gain competencies required by professional psychologists: (1) Professionalism; (2) Relational Skills, (3) Research and Science; (4) Clinical Skills; (5) Training & Supervision. Interns receive two hours of individual supervision per week with a licensed psychologist. Interns also receive two hours per week of group supervision at the Friday morning Psychology Resident Meeting. Intake assessments were conducted in both the outpatient clinic as well as assisted with weekend intake assessment at the Crisis Recovery Unit, Psychiatric Hospital.

- *Title: Honoring Undocumented Latinas' Resiliencies: Impacts of Anti-Immigrant Oppression and Healing Through Culturally Responsive Group Therapy*
- *Description:* This research assessed how undocumented Latina immigrants living in Arizona are a population at extensive risk for adverse psychological, social, emotional, physical, and spiritual health effects, particularly given the current sociopolitical context of anti-immigrant legislation. This study explored (1) narrative themes from testimonials of recently deported undocumented Latina immigrants ( $N = 60$ ) to Nogales, Sonora, Mexico; and (2) process themes generated from a culturally and spiritually responsive pilot group therapy program for undocumented women of Mexican descent ( $N = 6$ ) living in Southern Arizona. Mixed methods design was employed, using: (1) phenomenological qualitative assessment of deported immigrant testimonials and group therapy process themes, and (2) quantitative analyses using a paired samples  $t$ -test demonstrates effectiveness of group therapy by comparing pre and post group trends. Assessment measured ethnic identity development, acculturation, victim schema perceptions, as well as trauma, depression, and anxiety symptoms. Findings reveal the

following risk factors: (a) civil and human rights violations; (b) cycle of oppression, marginalization, poverty, and violence; and (c) impaired psychosocial functioning. Results reveal group therapy enhanced the following protective factors through: (a) acknowledgement of Indigenous and collective strengths (b) promoting resiliency, coping, and action via empowerment and transformation processes; (c) meaning making processes that restored hope, spirituality, trust, openness, social support, and family integration; and (d) improved psychological, social, physical, emotional, and spiritual health that demonstrate culturally and spiritually responsive group therapy had a positive impact and overall effect. Implications for advocacy, education, healers, culturally responsive intervention, social justice, restoration of civil and humanitarian rights, and anti-immigrant legislature and policy reform are addressed.
